Good News About Women on Corporate Boards in California - Again!

May 12, 2008 --- Santa Monica, CA -- Champion Boards reports continued progress among California top public companies in their appointment of women to corporate boards of directors.

The 2008 Fortune 1000 List of top U.S. companies was released online this week during the last week of April. The print edition was available May 5, 2008.

A total of 146 women hold director seats at California's 103 top F1000 firms, for an average of 14.0% as of April 2008. This is 23 more women (12.2%) than was reported in 2006.

A continuing pattern this year is that the top tier F500 firms demonstrated a higher share (16%) of women on their boards as contrasted with the lower tier of F501-1000 firms (11.6%). This has been a consistent pattern for a number of years.

The progress has been especially positive in light of the tremendous upheaval in the California economy (a reflection of national trends). Twelve companies left the California F1000 list (taking 9 women directors with them). The departing companies averaged only an 8% share of women holding board seats.
